THREAD ENROLLS STUDENTS WHO RANK IN THE BOTTOM 25% OF THEIR CLASS AND WHO FACE AN ABUNDANCE OF CHALLENGES OUTSIDE OF THE CLASSROOM INTO ITS MENTORSHIP PROGRAM DISRUPTING THE PATTERN OF ISOLATION THAT LEADS TO ACADEMIC UNDERPERFORMANCE. STUDENTS REMAIN IN THREAD FOR 10 YEARS, SURROUNDED BY A GROUP OF UP TO FIVE VOLUNTEERS, A THREAD FAMILY, THAT PROVIDES THE STUDENT WITH CONTINUOUS SUPPORT AND INCREASED ACCESS TO COMMUNITY RESOURCES WHILE DEEPLY ENRICHING THE LIVES OF COMMITTED VOLUNTEERS. 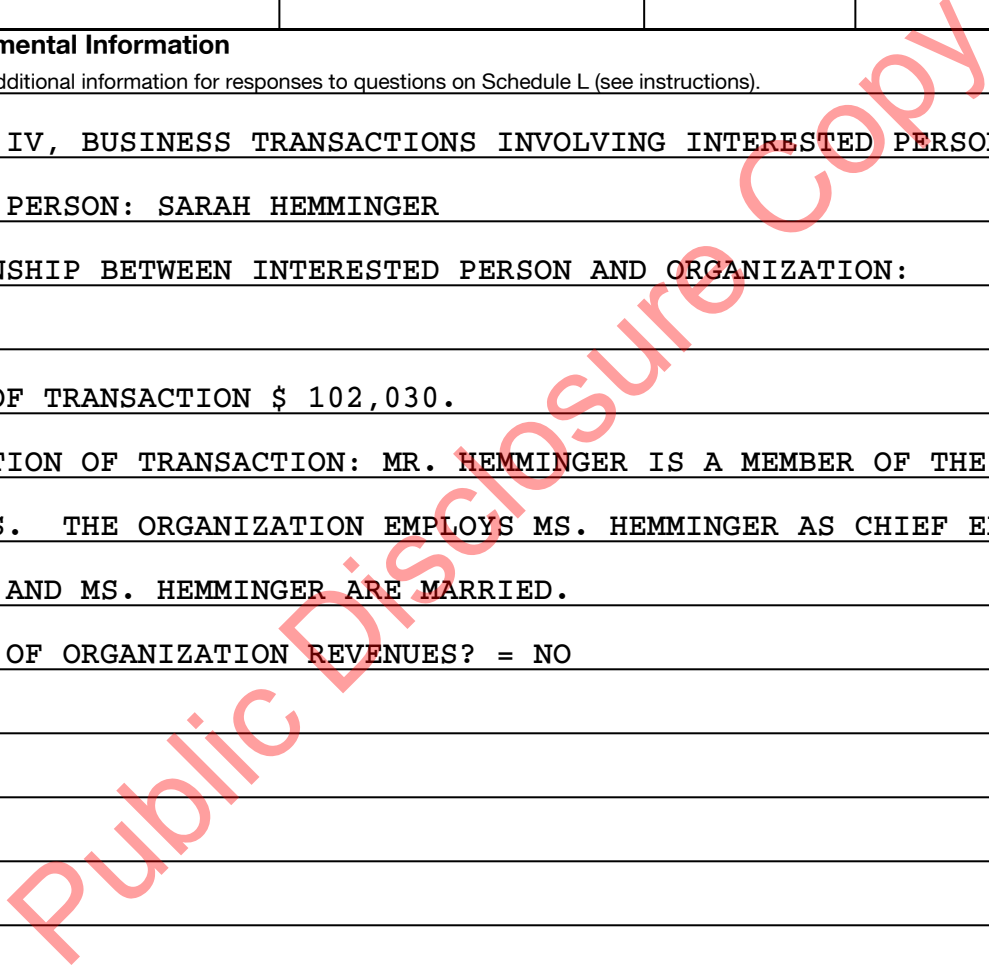

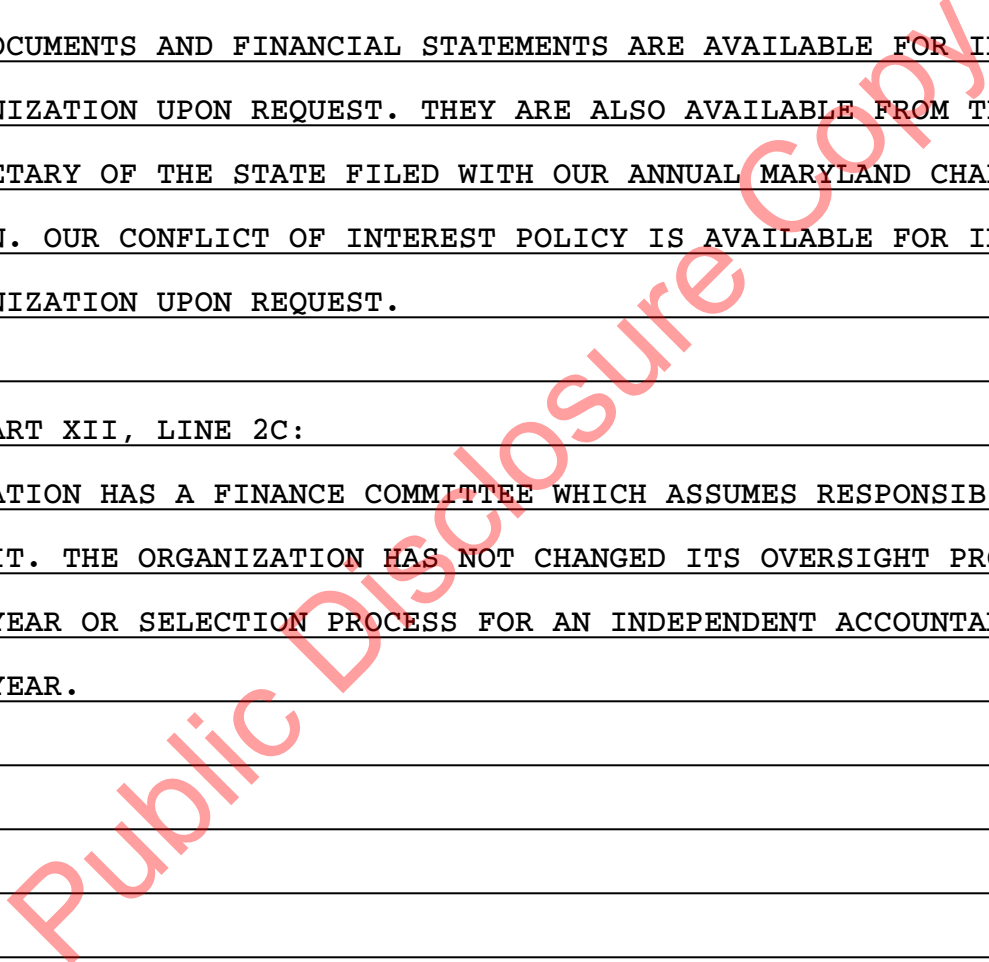
